**Call for Nominations – Submission Deadline October 1<sup>st</sup>**

**Save-the-Date – Thursday, October 22, 2020 – Zoom Election Day**

In accordance with the Bylaws of the Staten Island Multiple Listing Service, Inc. (SIMLS), four (4) director positions on the *2021 SIMLS Board of Directors* will be filled by a vote of the SIMLS Participants (to be conducted electronically) on October 22, 2020.

Any MLS Participant who is a SIBOR member in “good standing” **and** who will not be serving on SIBOR’s 2021 Board of Directors, may submit their name to fill an Elected Director position.

**Any qualified person submitting their name will be placed on the ballot.**

There are four (2-year) terms – January 1, 2021 thru December 31, 2022 – to be filled.
