### Staten Island Community Hurricane Ida Disaster Relief

The Staten Island Board of REALTORS® is helping those displaced by Ida's flooding. Have you been negatively affected by Hurricane Ida and need housing assistance? You may be eligible to receive housing assistance. SIBOR, in partnership with the REALTORS® Relief Foundation and New York Association of REALTORS® is providing assistance to those in need.

Assistance is available to qualified applicants towards one of the following options:

- 1) Monthly mortgage expense for the primary residence that was damaged by the Hurricane Ida Disaster or;
- 2) Rental cost due to displacement from the primary residence resulting from the Hurricane Ida Disaster. Relief assistance is limited to a maximum of \$2,000 per applicant per household.

## REALTORS® RELIEF FOUNDATION

### Application for Disaster Relief Assistance

***Type of Assistance***

Assistance is available to qualified applicants towards one of the following options: 1) Monthly mortgage expense for the primary residence that was damaged by the Hurricane Ida Disaster or; 2) Rental cost due to displacement from the primary residence resulting from the Hurricane Ida Disaster. Relief assistance is limited to a maximum of \$2,000 per applicant per household. Deadline for application submission is October 31, 2021. Please note this assistance is for housing relief only; other expenses including second mortgages(home equity lines or loans), hotel/motel expenses, clothing, appliances, equipment, vehicle purchase, rental or repair and or mileage are ineligible for reimbursement under this program.

***Eligibility***

Recipient must be a full-time resident and U.S. citizen or legally admitted for residence in the United States.

***Confidentiality***

All information provided on this form will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance to be provided. This includes providing a copy of this application to the applicant's lender or landlord, if requested. It will not be shared with other parties for any other purpose.

***Disbursement of Funds***

In order to provide for a reasonable and equitable distribution of funds, assistance will be provided on a first come, first serve basis. All grants are contingent upon the availability of funds. Grants will be jointly payable to applicant and mortgage lender or landlord.

### Attachment Checklist

1. Photo Identification to Show Proof of Residency [i.e.. driver's license or other governmental documentation evidencing residency]
2. Copy of Mortgage Statement or Mortgage Payment Coupon or Rent Statement or Lease Agreement

***One of the Following is Required to Show Proof of Damage to your Primary Residence:***

- a. Photos of Damages
- b. Insurance Estimate
- c. Copies of Written Claims, Settlement Proceeds or Claim Status Reports
- d. Copies of Repair Estimates from Contractors
