2022 SIBOR COMMITTEES & TASK FORCES

Bylaws (CHAIR 2022: Georgianna Diaz; VICE CHAIR: Frank Reali)

Reviews the Bylaws, Governance, Policies and procedures and makes recommendations to the Board of Directors.

Consumer Awareness (CHAIR 2022: Fran Reali; VICE CHAIR: Annmarie Triolo)

Creates and delivers programs to make consumers aware of the real estate buying, selling, leasing and renting experience and helps set expectations for the expected service from REALTOR professionals.

Consumer Experience (CHAIR 2022: Scott Setaro; VICE CHAIR: Jeff Stanton)

Identifies and implements programs and services to help members improve the professional services they provide to consumers.

Diversity, Equity & Inclusion (CHAIR 2022: Angelo Pappalardo; VICE CHAIR: TBA)

Works to increase awareness and appreciation of the multicultural diversity of our community as well as eliminating discriminatory practices in housing.

Global Real Estate Council (CHAIR 2022: Rocio Uchofen; VICE CHAIR: TBA)

Dedicated to globally themed education, programming and networking. Works to build awareness of the global business opportunities. Manages the relationship SIBOR has with real estate professionals in countries where SIBOR is the Liaison Association (currently Israel) assigned by the National Association of REALTORS.

Golf Outing Fundraiser (CHAIR 2022: Joe Tirone)

Runs the annual SIBOR Golf Outing as a fundraiser for a worthy local charity.

Gov't & Legislative Affairs (CHAIR 2022: Frank Reali; VICE CHAIR: TBA)

Identifies and raises awareness with elected officials of proposed legislation or local ordinances that affect real property rights or threats to our profession. Works with RPAC Committee to disburse RPAC funds to candidates and elected officials.

RPAC Realtors Political Action Committee (CHAIR 2022: George K. Wonica; VICE CHAIR: TBA) Raises awareness of the importance of the Realtor Political Action Committee (RPAC), creates fundraising events and develops initiatives to increase members voluntary RPAC contributions. Works with Gov't & Legislative Committee to disburse RPAC funds to candidates and elected officials.

Grievance Committee (CHAIR/VICE CHAIR 2022: Elected by the Committee)

Performs initial review of complaints and claims (filed by Realtors and the Public) regarding un-Ethical conduct and financial disputes, referring them, when appropriate, to the Professional Standards Committee for hearings. Realtor participants must be licensed for a *minimum* of three (3) years <u>and</u> are typically required to complete a training program with details to be determined.

Nominating & Awards Committee (CHAIR 2022: Scott Setaro)

Identifies & nominates annual recipients of the Realtor® and Realtor Associate®-of-the-Year, and other Recognition Awards; recruits and nominates future board Leadership. Participants must be a Realtor or Realtor Associate member of SIBOR for past four (4) years.

Professional Development (CHAIR 2022: Vinny Zaloom; VICE CHAIR: Valerie Vargas)Develops and recommends educational programming, speakers, and events to enhance the professional development of our members with a concentration on the Broker Owner/Manager.

Professional Standards (CHAIR 2022: Maureen DiTuri)

A pool of volunteers is used to compose hearing panels that arbitrate disputes and conduct Code of Ethics hearings in accordance with procedures established by the National Association of Realtors[®]. Realtor participants must be licensed for a *minimum* of three (3) years <u>and</u> are typically required to complete a training program with details to be determined.

Public Advocacy (CHAIR 2022: Angelo Pappalardo; VICE CHAIR: Robert Kelly)
Investigates and/or creates programs to make the public aware of threats, legislative and/or regulatory, to private property rights.

Realtor Day & Trade Show (CHAIR 2022: Fran Reali; VICE CHAIR: Gary Fleming)
Facilitates the Annual Vendor Fair in conjunction with the Top Producer Club Awards
Ceremony.

Young Professionals Network (CHAIR 2022: Danielle Denigris; VICE CHAIR: TBA) Provides an opportunity for real estate professionals newer to the industry, to *enhance* their career via networking, education and community service. Helps to identify and develop future leadership for our association.
